VILLAGE OF EPHRAIM  
ORDINANCE NO. 04-2018  
AN ORDINANCE AMENDING VILLAGE OF EPHRAIM ZONING CODE AS IT RELATES TO SIGNS

SECTION I: § 17.09 of the Ephraim Code of Ordinance is hereby amended by addition of language as follows:

***ADDITIONS IN BOLD ITALICS***

**17.09 DEFINITIONS.**

***Downlighting. Any fixture aimed in such a way as to project the light downward below the horizontal plane passing through the lamp.***

SECTION II: § 17.15 of the Ephraim Code of Ordinance is hereby amended by addition of language as follows:

***ADDITIONS IN BOLD ITALICS***

**17.15 SITE AND DEVELOPMENT STANDARDS**

...

**(18) SIGNS**

...

(d) Prohibited signs and characteristics of signs.

...

3. No sign shall be lit in such a way as to impair driver visibility on public roads.
4. ***Existing*** sources of sign illumination (***as of the date of publication of this ordinance amendment***) shall be so shielded ***as not to see the source of illumination and*** as to cast reflected light on the face of a sign without the direct light source being seen from adjoining roads.
5. ***Existing sign illumination determined by the planning committee to be out of compliance with par. 4(above) may be required to install new lighting pursuant to par. 6 (below).***
6. ***All new sources of sign illumination shall be so shielded as not to see the source of illumination and as to cast reflected downlighting on the face of a sign without the direct light source being seen from adjoining roads.***

**SECTION III:** If any section, subsection, paragraph or sentence of this ordinance is for any reason deemed unconstitutional or otherwise unenforceable by decision of any court of competent jurisdiction, such decision shall not affect the validity of the remainder of this ordinance.

**SECTION III:** This ordinance shall take effect upon its passage and publication according to law as an amendment to the Village Zoning Code under the procedures prescribed by § 62.23 (d) Wis. Stats.
