## VILLAGE OF EPHRAIM MARINAS AND MOORINGS MINUTES WEDNESDAY, JUNE 5, 2024 – 8:00 AM 9996 Water Street- Ephraim Village Hall



#### Action Items:

**B.** Nelson moved, Thorp seconded to approve the minutes of May 8, 2024, as presented, all ayes. Motion carried.

#### Thorp moved, B. Nelson seconded to adjourn at 9:40 AM, all ayes. Motion carried.

Present: John Held, Bruce Nelson, BD Thorp, Robert Plansky. and Tim Nelson - Chair.

Absent: None.

Guests: Frederic Schmidt (online) and Jennifer and Kimon Miller.

Staff: Brent Bristol - Village Administrator/Harbormaster.

- 1. Call to Order: The meeting was called to order by T. Nelson at 8:00 AM.
- 2. Changes to the agenda: There were no comments.
- 3. Visitors' Comments: There were no comments.
- 4. Approval of the previous minutes:
  B. Nelson moved, Thorp seconded to approve the minutes of May 8, 2024, as presented, all ayes. Motion carried.

#### 5. Update regarding current projects:

Bristol provided an update on the Physical Facilities and Utilities "PFU" Committee project which created new trailer parking at the German Road site. He explained that he hoped that the M&M committee would participate in the logistics to make the project a success. It was built to clear up some space at the Wastewater Plant. To utilize the space to its full potential, it will be important to ensure appropriate trailer parking.

A discussion was held regarding the German Road project. Discussion included communicating concerns to the PFU committee, whether PFU would agendize the items for discussion for an upcoming meeting, and maps on the posting board down at the marina which could provide information about how to park at the German Road site for marina customers.

Further discussion included Jeff Long, billing from Long, Long's plans to get everything finalized for the Village on Monday, items that have to be completed by Long by next weekend, channel markers and the red buoys that needed placement review by Long, dock staff uniform shirts to be worn again this year, and how Village staff reports their time. Additional discussion included having the treasurer reach out to Long regarding billing.

Bristol explained that Kahr completed the remaining projects at Firehouse Marina and Anderson Dock. He informed the committee that Kahr had sold his business to Somerset Marine. Kahr will stay to assist with the municipal clients for at least a year, maybe longer. He shared that Kahr felt the sale was a good thing for Door County because there would be more people to do the work with the larger company.

Bristol shared that seasonal dock staff have started work, they have met with the Assistant Harbormaster, and a schedule has been worked out. Succession planning was discussed; a fill-in person for this year could be a permanent person for next year.

Held shared his concern that the office is frequently open with no one there; it should be locked when they are not there.

#### 6. Discussion and consideration regarding the Clean Marina Program:

B. Nelson shared an update on the Clean Marina Program. He noted that once the training portion is complete they can schedule the onsite visit with the Administrator of the program.

A discussion was held regarding the training process. B. Nelson, Bristol, and the Assistant Harbormaster would work together to undertake and document the training.

#### 7. Discussion and consideration regarding new projects (building siding):

T. Nelson explained that he had brought up the question of the marina building siding at the last Board meeting. He had asked the Board to consider the options and communicated that the committee had approved the pressure washing of the cedar shakes.

A discussion was held regarding the marina building siding. Held asked if a quote would be needed. T. Nelson felt that it would be useful but didn't think it would be available before the meeting.

Bristol provided an update on village-wide striping, which included work at the marina. He noted that they would work on determining an appropriate rotation schedule going forward.

## 8. Discussion and consideration regarding Anderson Dock Capital Project Elements (utility trench, monument corner, and others):

T. Nelson updated the Committee that the Request for Proposal has been sent out. Kahr had made a recommendation regarding the floating slips/piers. They are not constructed in a way that allows long-term maintenance. He felt they had five (5) to ten (10) years of useful life left. T. Nelson explained that should be looking at a plan at budget time to start putting money aside for replacement. At a certain point, they aren't worth repairing.

A discussion was held regarding dredging. Bristol suggested considering maintenance dredging at Anderson Dock so that we don't end up with a larger bill down the road. B. Nelson suggested finishing dredging at Firehouse Marina as well. The work was completed to allow the dinghies to come in but there is still a hazard. Bristol noted that he thought the permit was good for two (2) years. Held suggested the work be completed in the fall. The committee further discussed the permissible dredging work period as designated by the WI DNR.

T. Nelson noted that the breakwater is still being explored. It is in Kahr's hands to come up with a proposal and determine if it would be permitted.

#### 9. Discussion and consideration regarding the Slip Transfer Policy:

Bristol noted that this has been discussed previously but questions have arisen. He would like to affirm the policy for Slip Transfers. Currently, slips are allowed to transfer laterally, meaning husband to wife or wife to husband. The slip cannot be passed on or transferred to future generations. Bristol provided background regarding a situation of ownership. To qualify as a resident there has to be one name on the boat slip but they could be part of an LLC that owns property in Ephraim to satisfy the residency requirement. An LLC or partnership group could not have a slip in the marinas. Bristol explained that he was confident those were the parameters that the committee previously discussed. Because it was brought up recently, he wanted affirmation from the committee that they want to continue with the policy.

A discussion was held regarding the Slip Transfer Policy. B. Nelson noted what Bristol outlined is what is in Chapter 20.04(8) of the Marinas and Moorings Ordinance. B. Nelson stated that it was the ordinance, not a policy. Held agreed; it allows for some turnover. Held asked for the applicable portion of the ordinance to be reflected in the minutes:

§20.04(8) - Space shall be assigned to the person whose name appears on the contract and for the boat listed (person means natural person, not corporation, partnership, or LLC). Space will not be transferred to another person, except an estate may continue to use the mooring until the completion of the season. A surviving spouse may continue a rental as long as these rules are complied with. Space may be transferred to a different boat of the same owner, subject to the approval of the Village of Ephraim, when a larger or smaller space is required, the Village of Ephraim may give preference to such change. No mooring owner may rent or loan out the use of his or her space. Any such action will be deemed a

# violation of this ordinance. A \$25 per day penalty will be assessed. All space is otherwise not transferable. A continued violation of this ordinance is subject to removal of a mooring and termination of the contract.

Further discussion was held regarding the Slip Transfer policy. T. Nelson asked if the reference to the ordinance should be a part of the application process to stress that applicants are doing this for them, not their grandchildren. Bristol noted that it is a long endeavor to get a slip. From a waitlist standpoint, people are asking what name to put on their applications, myself, kids, or grandkids. His opinion is people can put the name they want to put on the application but at the time a slip becomes available, that person has to own property in the Village. He asked the committee if they were comfortable with that.

Frederic Schmidt stated his daughter is on the list and she is not a property owner. He felt that they did not need to be a property owner at the time they joined the list, just when a slip became available. He deferred to Brent to clarify.

A discussion was held regarding the marina waitlist. Bristol clarified if the family owns property in Ephraim, that's ok, but when the name on the application comes up for a slip, at that point they have to own property in Ephraim. If the succession of property ownership has not evolved at that point, then the applicant is not eligible for a slip. Bristol noted that it is very possible since the wait list is so long that there are people who signed up for a slip on the resident list that no longer own property in Ephraim. That is part of the due diligence, he stressed. Thorp asked if there were any non-resident slip holders. Bristol stated not to his knowledge. There are non-resident mooring holders. A non-resident will always be at the bottom of the list; it is never going to happen. They are not property owners.

Schmidt discussed the waitlist and asked if there was a fee to stay on the waitlist. If there was not, he suggested that it be implemented to ensure that people are serious.

Bristol stated the application fee used to be refundable and it was changed to non-refundable to ensure that people were serious about joining the list.

Held felt that it would be difficult to administer.

Bristol said that Dockwa is working on a waitlist feature.

Thorp stated that transient dock slips should be decreased in available length in Dockwa to account for the length overall "LOA". People only account for their length and not LOA when booking a transient reservation.

Bristol added that he would continue training and discussing with staff how to tie up with both seasonal and transient slip holders. He further discussed making notes in Dockwa to prevent future issues.

Jennifer Miller shared her experience with the Michigan Waterways and the strictness of the requirements of the vessel being within the confines of the slip.

Held suggested updating the Dockwa listing to," If you check in and your boat is longer than the slip that you have reserved you will be either moved to a larger slip at an additional expense or if there is not an appropriate length slip available, you will not be permitted to stay." Additionally, the LOA explanation should be where the customer enters their boat length.

Bristol stated that he would look into the ability to add additional details and a disclaimer. He suggested an onsite meeting when the marina is full to review operations. If there was nothing actionable for the next, regular meeting, the onsite meeting could serve as the monthly meeting.

#### 10. Discussion and consideration regarding storage for marina equipment:

Bristol noted that PFU was looking at, as part of the five (5) and ten (10) year Capital Plans, facility recommendations. The current recommendation is to investigate a new building for maintenance on the same property, in a different location. Then to offer the current maintenance space to Wastewater. That will be evolving as the concept is looked at. If marinas require space, a discussion needs to happen about what type of space is needed. We need to look at what needs to be stored and how it needs to be stored. Does the committee want to pursue dedicated space, he asked.

Held stated he would like to go on the record that the buoys need covered space.

A discussion was held regarding marina equipment. The committee discussed which equipment could be stored inside and what could be stored outside, covered. Held requested that Bristol advocate on behalf of the committee that at the very least they needed covered space and to consider marinas and moorings as the project moves along. Coming up with a specific number of square feet will be more challenging; it needs to be accessible and covered. B. Nelson noted that customer mooring balls are also being stored and those should be covered as well.

#### 11. Update regarding Customer List and Waiting List:

Bristol explained that the customer list was in the binder that B. Nelson had with the organizational and operational materials needed for Clean Marina. There also was a copy down at the marina office. He discussed that he is working on something to satisfy waitlist customers to achieve the request for transparency through Dockwa.

B. Nelson stated that for quick access, customer lists should be separated by marina and by customer. He felt the list was incomplete; he would work with Roberts.

Bristol noted that all the customer contacts are in Dockwa; it is the best resource but redundancy is good to offer multiple sources of information.

#### SUMMARY OF CLEAN MARINA MEETING ON 7-30-2024

Thresa Qualls and Vicki Harris from theClean Marina Program Brent Bristol, Stephan Reynolds, and Logan from VOE John Held, and Bruce Nelson Marina Committee

We met at the FH marina and toured both marinas. We discussed all pages of the program checklists for both the FH and Anderson marinas. Actions required for certification were listed and suggestions for changes to our documents were made.

#### MARINA ENVIRONMENTAL POLICIES

Suggested wording to be removed in red

#2. Owners may undertake boat projects as needed to maintain their vessels safety, appearance, and utility. New or substantial exterior work encompassing more than 25% of the hull's surface must be reviewed and approved by the Marina. Any sanding or grinding of the vessel's surface requires Marina approval.

Consider adding "Sanding and grinding are prohibited in the marina".

#### 5. PAINTING AND VARNISHING

- a. Limit the amount of open solvents or paints on the dock to one gallon.
- b. Always mix paints and epoxy over a tarp.
- c. Always use a drip pan and drop cloth.
- d. Spray painting is not allowed within the marina.
- e. Use up the remaining paint by spreading it on an old board.
- f. Do not dispose of paints/solvents in the marina's dumpsters.
- g. SPECIAL DISPOSAL CONTAINERS ARE AVAILABLE SEE STAFF FOR ASSISTANCE.

#### 6. SURFACE PREPARATION

- a. Use biodegradable cleansers and teak cleaners.
- b. Liberally use tarps to capture all scrapings, debris, and drips.
- c. Stretch tarps between the side of the boat and dock when working over the water.
- d. Vacuum dust and debris every time you move the tarp or every hour.

#### 9. CHEMICAL STORAGE

- a. Purchase only the amount of chemicals/paint you need for the project.
- b. Do not store chemicals, including paint and varnish, or fuel in dock box.

11. Do not store more than 3 gallons total of paint and solvents.

Consider adding new item # -----

"Feeding birds is not permitted in the marina."

#### **RULES & REGULATIONS**

Suggested changes

8. MAINTENANCE: Owner and/or subcontractor are permitted to perform routine maintenance on his/her vessel. All work must comply with the Marina's Environmental Best Management Practices, a copy of which is available at the Marina or via request. Any project involving the vessel's surface or sanding/grinding of any of the vessel's surfaces requires prior approval from the Harbormaster or Assistant Harbormaster. Only light maintenance shall be allowed while the vessel is in slip in a manner that does not disturb, damage, endanger, or interfere with other vessels, their owners, the Marina, and facilities, or any other natural or man-made resource.

Consider adding "Sanding and grinding are prohibited in the marina".

#### Actions Required for Certification:

Post sign indicating what may not be placed in trash containers (TQ will provide) Need updated emergency response plan and environmental rules Post signs (TQ will provide) informing boaters on best management practices. Add oil spill booms to encircle the largest boat in the marinas. Add 60 feet of boom.

#### Additional suggestions:

Consider adding rain barrels to the FH marina office

Answer each question by checking either Yes, No, or N/A. The "not applicable" (N/A) option is offered so items that do not apply to your operation will not be tallied in the certification score. For example, some checklist items under the "petroleum control" chapter apply only to marinas with fuel docks.

## **TRAILER PARKING:**

- **DAILY PARKING: 10011 Norway Street**, on the north side of the driveway behind the Ephraim Fire Department building. This site is intended for day parking of trucks and trailers. **No overnight parking is permitted.**
- **OVERNIGHT PARKING: 10285 Townline Drive**, on the south side of the driveway of the Ephraim Wastewater Treatment Facility. This site is intended for long and short-term parking of trailers. It is a good idea to reach out to the Public Works Supervisor (920-854-0154) to ensure that there is space for your trailer.

#### Coast Guard Station Sturgeon Bay

Approximately 30 active duty and reserve members answer the call, providing Search and Rescue assistance, Law Enforcement, Ice Rescue operations, and protection of infrastructure critical to the maritime environment of the United States.

Station Sturgeon Bay's area of responsibility (AOR) is encompassed by a line from the shoreline of western Lake Michigan at 44-29.0'N to 44-20.0'N 087-00.0'W to 45-47.5'N, 086-22'W (Point Aux Barques), thence southerly along the shoreline to the point of origin and including all of Green Bay. When Station Washington Island is open it assumes Station Sturgeon Bay's AOR northwest of the line from 45-05.3'N 086-33.0'W to 45-05.3'N 087-02.8'W (Cana Island Light) to 45-10.1'N 087-14.2'W (Eagle Bluff Light) to 45-15.2'N 087-29.8'W. Auxiliary Station Green Bay falls within Station Sturgeon Bay's AOR.

# ► EMERGENCY RESPONSE EQUIPMENT

Ephraim Marina owns the necessary equipment to contain a small hazardous materials spill or other similar accident. The spill kit is located at Firehouse Marina. All spills requiring special boom materials should be immediately reported to the US Coast Guard Station Sturgeon Bay (920-743-3367) and the Wisconsin DNR (Mike Neal - 920-559-0735).

#### FIREHOUSE MARINA:

Firehouse Marina dock staff will assist in locating necessary spill kit items. The spill kit is located in the dock box on the North side of the marina office building. If a spill occurs at Anderson Marinas, please contact dock staff for assistance in obtaining spill kit items.

# ► THE MARINA PIERS DESCRIPTION

# FIREHOUSE MARINA:





Firehouse Marina has fourteen (14) floating finger piers.

# **ANDERSON MARINA:**



• Anderson Marina has six (6) floating piers and one (1) wall tie.

Depending on the level of the Lake, the typical water depth in both marinas is 5' to 8'. The channel depth ranges are from 5' to 8' in both marinas. The mooring field ranges in depth from 8' to 15'.

# ► ELECTRICAL POWER:

### FIREHOUSE MARINA:

• Emergency Power shut-off is located inside the marina office building.

#### **ANDERSON MARINA:**

• Emergency Power shut-off is located at the rear of the Anderson Store. Key access is required, please contact Firehouse Marina staff for assistance.

# ► EVACUATION AND FIRE FIGHTING EQUIPMENT:

There is a single, by-foot evacuation route for all piers at the Ephraim Marinas that is via the ramps at the bulkhead. In the event of an emergency requiring evacuation, if this route is not available, departure by a vessel located at a minimum of 100' from the incident is recommended. Boats within the 100' area should not have their engines started to be moved.

# FIREHOUSE MARINA:

• A Fire extinguisher is located inside the marina building. Additional fire extinguishers are located on each pier.

### **ANDERSON MARINA:**

• A Fire extinguisher is located on a post near the fire boat.

# ► FIRE EMERGENCY PLAN: INCLUDES BOAT FIRES AT THE PIER

#### 1. THE PERSON DETECTING THE FIRE ANNOUNCES "I AM IN CHARGE".

a. Immediately assign a particular person to call 911.

### 2. CALL THE FIRE DEPARTMENT – DIAL 911

- a. Give the following information:
  - i. "This is (insert your name) at the (insert correct marina: EPHRAIM FIREHOUSE MARINA AT 9970 STH 42, EPHRAIM OR ANDERSON DOCK MARINA, 3081 ANDERSON LANE) EPHRAIM Wisconsin. The Marina telephone number is 920-854-6861. We have a BOAT FIRE ON A PIER (identify which pier).
- b. Describe the size of the boat and type: power or sail.
- c. Describe the severity of the fire and if other boats are near the fire.

# 3. PERSON IN CHARGE:

- a. Notify all on-duty marina staff and Harbormaster/ Assistant Harbormaster: "We have a fire at (insert correct marina: **FIREHOUSE MARINA** *OR* **ANDERSON DOCK MARINA**).
- b. Assign one person staff first, customer if needed, to clear the pier of all persons.

# 4. LIFE SAFETY:

- a. Remove any injured persons away from the fire area IF THERE IS ANY FURTHER DANGER TO THEM FROM THE FIRE.
- b. Shut off electrical power- if appropriate.
- c. Evacuate boat owners and guests from the affected Pier.
- d. Assign a Staff member to man the driveway to direct incoming fire crews to the appropriate area.
- e. Secure any burning boats to the dock ONLY IF THIS CAN BE DONE SAFELY.
- f. Remove adjacent boats ONLY IF THIS CAN BE DONE SAFELY. Do not start boats that are immediately adjacent to the burning boat.

### 5. ENVIRONMENTAL SAFETY:

- a. Call 911.
- b. Call USCG National Response Spill Number: 1-800-424-8802
- c. Locate fuel and oil spill containment and clean up equipment and deliver to the fire site.
- d. Use fuel and oil containment equipment (booms) to contain any spilled fuel ONLY IF THIS CAN BE DONE SAFELY.
- e. If a major spill event is taking place, boom the entrance to the marina.

### 6. FOLLOW UP:

a. Once the area and event are properly secured perform follow-up procedures:

- b. Complete an Incident Report Form.
- c. Contact Harbormaster-if not on site.

# ► GENERAL GUIDELINES FOR FUEL SPILLS:

# **GASOLINE:**

- 1. For smaller gasoline spills (less than five (5) gallons, allow it to evaporate. Do not try and confine.
- 2. For a larger gasoline spill:
  - a. Call 911.
  - b. Attempt to contain the spill using the on-site spill kit. The spill kit is located at the Firehouse Dock in the dock box on the North side of the building.
  - c. Shut off electrical power to the nearest areas.
  - d. Guard the area until safe from fumes and fire.
  - e. Report details to the U.S. Coast Guard at 920-743-3367 and the National Marine Pollution hotline at 800-424-8802.

# DIESEL:

- 1. Call 911.
- 2. Attempt to contain the spill using an on-site spill kit. The spill kit is located at the Firehouse Dock in the dock box on the North side of the building.
- 3. Exclude boats and swimmers from the containment zone.
- 4. Report details to the U.S. Coast Guard at 920-743-3367 and the National Marine Pollution hotline at 800-424-8802.
- 5. For larger quantities that can be contained in the Marina's spill kit:
  - a. Contact the US Coast Guard immediately at 920-743-3367 and the National Marine Pollution hotline at 800-424-8802.

# ► GENERAL RESPONSE: FOR ALL EMERGENCIES

PERSON FIRST DETECTING ACCIDENT OR FIRST NOTIFIED OF INCIDENT:

# Determine severity and if authorities need to be immediately contacted.

# IF AUTHORITIES ARE REQUIRED:

- 1. Call 911.
- 2. The person in charge announces that they are "in charge".
- 3. Appoint one person to direct emergency crews to the appropriate area when they arrive.
- 4. Clear the area of bystanders.
- 5. Notify on-duty staff and the Harbormaster/Assistant Harbormaster to assist as necessary.
- 6. Appoint one person to obtain the proper Incident Report Form and complete it as soon as possible.
- 7. Stay on-site until authorities arrive.

# 8. DO NOT MOVE OR ASSIST A VICTIM THAT MAY BE INJURED.

# IF AUTHORITIES ARE NOT REQUIRED:

- 1. Complete the proper Incident Report Form as soon as reasonably possible.
- 2. Issue completed form to Harbormaster to review and file.

# ► AUTOMOBILE ACCIDENT

IF THERE ARE ANY INJURIES OR DAMAGE TO PROPERTY CALL 911 IMMEDIATELY

# **EMERGENCY SITUATION:**

- 1. The staff member first contacted is in charge and should call 911 immediately.
- 2. Provide the operator with the pertinent information.
- 3. Go to the accident scene or appoint another staff member to do so.
- 4. Clear the area of spectators.
- 5. If there are injured victims, do not move a victim, emergency crews will do so.
- 6. Stand watch for emergency response.
- 7. Assist as necessary.
- 8. Complete the Incident Report form and submit it to Harbormaster.

# **NON-EMERGENCY SITUATION:**

- 1. The staff member first contacted is in charge and should remain calm and unbiased to diffuse any possible tension or confusion that may ensue.
- 2. As soon as reasonably possible complete the Incident Report form and submit it to Harbormaster.
- 3. Attempt to quickly disperse the public to lessen the appearance of a "scene".

\*\* If the situation is not emergent, phone the Door County non-emergency number at 920-746-2400.

\*\*\* In both situations notify all on-duty staff, Assistant Harbormaster, and Harbormaster.

# **BOAT FIRE AWAY FROM THE PIERS & MARINA**

- 1. If you are contacted by VHF radio it is most likely that the US Coast Guard Sturgeon Bay station will take over. Stand aside for assistance -only if requested.
- 2. If you are contacted by telephone, obtain the information required on the Incident Report form and relay it to the US Coast Guard Sturgeon Bay Station at 920-743-3367 or VHF Ch. 16.
- 3. Complete the Incident Report form and submit it to the Harbormaster.

# **BOAT SINKING IN THE MARINA**

# PERSON FIRST DETECTING SINKING OR SUNK VESSEL:

- 1. NOTIFY MARINA STAFF MEMBERS IMMEDIATELY DO NOT ATTEMPT TO BOARD THE VESSEL.
- IF THE VESSEL IS FULLY SUBMERSED CALL 911 AND THE US COAST GUARD AT 920-743-3367.
  - a. Give the following information:
  - b. This is (insert your name) at the (insert correct marina: EPHRAIM FIREHOUSE MARINA AT 9970 STH 42, EPHRAIM OR ANDERSON DOCK MARINA, 3081 ANDERSON LANE) EPHRAIM Wisconsin. The Marina telephone number is 920-854-6861.
    - i. We have a BOAT SINKING/SUNK ON A PIER (Identify which pier).
    - ii. Describe the size of the boat and type: power or sail.
    - iii. Describe the location of the boat and its status.

# 3. PERSON IN CHARGE:

- a. Notify all on-duty staff, Assistant Harbormaster, and the Harbormaster: "We have a sinking/sunk boat at (insert correct marina: Firehouse/ Anderson Marina").
- b. Assign one person staff first, customer if needed, to clear the pier of all persons.

# 4. LIFE SAFETY:

- a. Shut off electrical power.
- b. Determine if any persons are onboard the vessel and provide assistance to offboard if possible.
- c. Evacuate boat owners and guests from the affected Pier.
- d. Assign a Staff member to man the driveway to direct incoming emergency response crews to the appropriate area.
- e. Remove adjacent boats ONLY IF THIS CAN BE DONE SAFELY to provide access for recovery efforts.

# 5. ENVIRONMENTAL SAFETY:

- a. Call National Spill Number: 1-800-424-8802
- b. Locate fuel and oil spill containment and clean up equipment and deliver to the site.
- c. Use fuel and oil containment equipment (booms) to contain any spilled fuel ONLY IF THIS CAN BE DONE SAFELY.
- d. If a major spill event is taking place, boom the entrance to the marina.

# 6. FOLLOW UP:

- a. Once the area and event are properly secured perform follow-up procedures:
- b. Complete an Incident Report Form.
- c. Contact Harbormaster if not on site.

# ► BOATING ACCIDENT

# IF THERE ARE ANY INJURIES OR DAMAGE TO PROPERTY CALL 911 IMMEDIATELY

### **EMERGENCY SITUATION:**

- 1. The staff member first contacted is in charge and should call 911 immediately, followed by a call to U.S. Coast Guard Station Sturgeon Bay at 920-743-3367.
- 2. Provide the operator/USCG with the pertinent information.
- 3. If possible, go to the accident scene or appoint another staff member to do so.
- 4. If near shore, clear the area of spectators.
- 5. If there are injured victims, do not move a victim, emergency crews will do so.
- 6. Stand watch for emergency response.
- 7. Assist as necessary.
- 8. Complete the Incident Report form and submit it to the Harbormaster.

# **NON-EMERGENCY SITUATION:**

- 1. The staff member first contacted is in charge and should remain calm and unbiased to diffuse any possible tension or confusion that may ensue.
- 2. As soon as reasonably possible complete the Incident Report form and submit it to the Harbormaster.
- 3. Attempt to quickly disperse the public to lessen the appearance of a "scene".

# **BOMB THREAT**

### ACTION TO TAKE IMMEDIATELY

- 1. Evacuate the threatened area and do not allow anyone to re-enter once the area is cleared.
- 2. The staff member first contacted is in charge and should call 911 immediately. Provide the operator with all necessary information.
- 3. Stand watch for emergency response.
- 4. As soon as reasonably possible complete the Incident Report Form and submit it to the Harbormaster.

# ACTION TO TAKE IF TIME ALLOWED WHILE TALKING TO THE PERSON MAKING THE THREAT:

- 1. Ask the caller the following questions and write the answers for future reference:
  - a. When is it going to explode?
  - b. Where is the bomb right now?
  - c. What kind of bomb is it?
  - d. What does the bomb look like?
  - e. Why did you place the bomb in this location?
- 2. Record the exact words of the caller.

# ALL DOWNED POWER LINES SHOULD BE CONSIDERED SERIOUS. POWER LINES SHOULD BE PRESUMED ENERGIZED.

- 1. Evacuate the threatened area and do not allow anyone to re-enter once the area is cleared.
- 2. The staff member first contacted is in charge and should call 911 and Wisconsin Public Service immediately. Provide the operator with all necessary information.
- 3. Stand watch for emergency response.
- 4. If possible, ribbon off a generous area around any downed wires.
- 5. As soon as reasonably possible complete the Incident Report Form and submit it to the Harbormaster.

# DROWNING REPORT

- 1. The staff member first contacted is in charge and should call 911 immediately. Provide the operator with all necessary information.
- 2. Stand watch for emergency response.
- 3. Contact additional staff to clear the area of bystanders.
- 4. Attempt rescue only if considered safe for the rescuer and proper safety equipment is used. Bring a floatation device if rescue is attempted.
- 5. Assist in emergency response as necessary.
- 6. As soon as reasonably possible complete the Incident Report Form and submit it to the Harbormaster.

# ► HOLDUP/ROBBERY

Our Organization's Policy Regarding Robbery: "It is this marina's policy to comply with any demands made by a person attempting to rob this business or its staff. No attempts are to be made to safeguard property or money if there is any risk of physical harm to anyone; safeguarding life is the primary concern."

- 1. The staff member first contacted is in charge and should call 911 immediately. Provide the operator with all necessary information.
- 2. Stand watch for emergency response.
- 3. Contact additional staff to clear the area of bystanders.
- 4. As soon as reasonably possible complete the Incident Report Form to be submitted to the authorities and the Harbormaster.
- 5. Assist in emergency response as necessary.

# ► MEDICAL EMERGENCY

- 1. The staff member first contacted is in charge and should call 911 immediately. Provide the operator with all necessary information.
- 2. Stand watch for emergency response.
- 3. Contact additional staff to clear the area of bystanders.
- 4. If immediate assistance by a trained person is available, provide assistance. Do not move the victim unless absolutely necessary. An Automated External Defibrillator (AED) is available at Firehouse Marina. It is located on the South side of the office building by the women's bathroom. Use only if you are familiar with its use and the circumstances require its use.
- 5. As soon as reasonably possible complete the Incident Report Form to be submitted to the authorities and the Harbormaster.
- 6. Assist in emergency response as necessary.

# ► MISSING PERSONS

- 1. The staff member contacted should immediately refer to the Incident Report Form and complete the information based on what was provided by the contact.
- 2. Upon determination of the severity of the situation, contact the proper parties, including police or emergency response personnel, if necessary.
- 3. If no immediate action is taken, submit the completed Incident Report Form to the Harbormaster or the manager on duty.
- 4. Follow up within 24 hours with the person who initially filed the report. If no update or change has occurred, continue to follow up every 24 hours until the situation is resolved or authorities are brought in to take over the case. Continue to document follow-up calls.

# ► POISONING REPORT

- 1. The staff member first contacted is in charge and should call 911 immediately. Provide the operator with all necessary information.
- 2. Stand watch for emergency response.
- 3. Contact additional staff to clear the area of bystanders.
- 4. As soon as reasonably possible complete the Incident Report Form to be submitted to the authorities and the Harbormaster.
- 5. Assist in emergency response as necessary.

# ► POWER OUTAGE

# **DO NOT CALL 911**

# **CONTACT WISCONSIN PUBLIC SERVICE: 800-450-7240**

- 1. Shut off all power switches, lights, especially motors such as refrigerators, air conditioning units, heating units, and air compressors.
- 2. Prepare signs or use preprepared signs, to indicate that restrooms are closed due to a power outage and will resume use as soon as power is restored. Post on each door.
- 3. Remain on-site until power is restored or normal business hours are over.
- 4. Once power is restored, remove signs and turn the power back on to those items turned off.

# ► SLIP AND FALL INCIDENT

All slip and fall incidents are considered serious and should be treated as such. If a medical emergency exists due to a slip and fall, follow the guidelines for a <u>Medical Emergency</u>.

#### **NON-EMERGENCY RESPONSE:**

- 1. The staff member contacted should immediately refer to the Incident Report Form and complete the information based on that provided by the person filing the report.
- 2. Upon determination of the severity of the situation, contact the proper parties, including police or emergency response personnel, if necessary.
- 3. Submit the completed Incident Report form to Harbormaster. Provide a copy to the person filing the report, if requested.

### **EMERGENCY RESPONSE:**

1. Refer to page 16 for <u>Medical Emergency</u> and follow those procedures.

# VILLAGE OF EPHRAIM MARINA

# Marinas are now financially and legally liable for the consequences of contaminants entering the environment from their facilities.

Changing our environmental habits has a price. But an ounce of prevention is worth a pound of cure. Best Management Practices (BMPs) are an ounce of prevention. Clean-ups are a pound of cure. Penalties and fines are several pounds of cure. By adopting and following a set of BMP's the cost can be kept to a minimum and the environment will be protected. Please keep the following policies in mind while working on a vessel at the Ephraim Marinas.

#### MARINA ENVIRONMENTAL POLICIES

- All self-employed boat workers and independent contractors must register with, and receive approval from, Management before beginning any work on Marina property. A current Certificate of Liability Insurance with a minimum of \$1,000,000 is required on file. Contractors WILL NOT BE ALLOWED under any circumstances without proof of insurance.
- 2. Owners may undertake boat projects as needed to maintain their vessels safety, appearance, and utility. New or substantial exterior work encompassing more than 25% of the hull's surface must be reviewed and approved by the Marina. *Any* sanding or grinding of the vessel's surface requires Marina approval.
- 3. All vessel owners *are required* to adhere to the following BMP's. Please refer to the Wisconsin Clean Marina Boaters Tip Sheets for additional information and details:

#### 4. ENGINE AND BILGES

- a. Use absorbent bilge pads to soak up oil and fuel
- b. Recycle oil and diesel properly.
- c. Dispose of gasoline properly.
- d. Dispose of oil filters properly, they are not allowed in the regular garbage dumpsters.
- e. Do not discharge bilge water if there is a sheen to it.
- f. Do not dispose of any fuels, used oil or used filters in the marina's dumpsters.
- g. SPECIAL DISPOSAL CONTAINERS ARE AVAILABLE SEE STAFF FOR ASSISTANCE.

#### 5. PAINTING AND VARNISHING

- a. Limit the amount of open solvents or paints on the dock to one gallon.
- b. Always mix paints and epoxy over a tarp.
- c. Always use a drip pan and drop cloth.
- d. Spray painting is not allowed within the marina.
- e. Use up the remaining paint by spreading it on an old board.
- f. Do not dispose of paints/solvents in the marina's dumpsters.
- g. SPECIAL DISPOSAL CONTAINERS ARE AVAILABLE SEE STAFF FOR ASSISTANCE.

#### 6. SURFACE PREPARATION

- a. Use biodegradable cleansers and teak cleaners.
- b. Liberally use tarps to capture all scrapings, debris, and drips.
- c. Stretch tarps between the side of the boat and dock when working over the water.
- d. Vacuum dust and debris every time you move the tarp or every hour.

#### 7. <u>SEWAGE</u>

- a. Untreated sewage should never be discharged directly overboard.
- b. Store sewage in holding tanks, dispose of properly at pump out stations.
- c. Use shore-side facilities as often as possible.

#### 8. SOLID WASTE DISPOSAL

- a. Dispose of all garbage in proper shore-side receptacles.
- b. Paint cans with unused product must be disposed of as hazardous waste.
- c. Recycle glass, newspaper, and aluminum in specially marked dumpster.

#### d. SPECIAL DISPOSAL CONTAINERS ARE AVAILABLE – SEE STAFF FOR ASSISTANCE.

#### 9. CHEMICAL STORAGE

- a. Purchase only the amount of chemicals/paint you need for the project.
- b. Do not store chemicals, including paint and varnish, or fuel in dock box.
- 10. Review storage of paints and solvents every six months, and properly dispose of old or unnecessary products.
- 11. Do not store more than 3 gallons total of paint and solvents.

#### 12. FISH CLEANING.

a. Fish cleaning is not permitted in the marina.

#### 13. ONBOARD DISHWASHING AND BATHING

a. No excessive grey water discharging in the marina. Make all attempts to use soap without phosphorous. Showering on shore is encouraged.



#### 20.02 GENERAL PROVISIONS.

#### (1) JURISDICTION.

(a) The jurisdiction of the Village over the waters and shorelines of Eagle Harbor in Door County is shown on the map published by the U.
S. Engineers Office in Lake Charts Nos. 702-703, Lake Michigan, which is hereby adopted by reference as if fully set forth herein.

(b) Eagle Harbor is located in T31N, R37E and occupies portions of Sections 9,10,11,12,13,14, 15, 16, 13 and 24. Its waters are bound on the north by a straight line extending from the northernmost shore of section 9 to the north boundary line of Section 12. All portions of Chapter 15 refer only to that area.

#### (2) BULKHEAD LINE.

(a) On September 7, 1971, the Village Board established a bulkhead line along that portion of the shoreline of Eagle Harbor that lines within the boundaries of the Village. After approval by the State Department of Natural Resources, a complete description and map of that line were recorded by the Registrar's office of Door County of November 16, 1972. This line separates the jurisdiction of the State from that of public or private riparian rights proprietors to the waters of Eagle Harbor.


(b) A riparian owner may place fill or structures on the bed of the harbor out to the bulkhead line after first making appropriate application to the DNR as required by law making certain that such improvement shall not be deemed to impair navigation or be detrimental to the public interest. Such application shall be subject to Plan Committee review.

#### 20.03 DOCKS COMMITTEE.

(1) <u>POWERS & DUTIES.</u> The Docks/Coastal Management Committee shall be responsible, with the Village Board approval, for the development, maintenance and operation of all municipal harbor facilities on such shorelands of Eagle Harbor as lie within the boundaries of the Village of Ephraim. The Committee may require policing the waters of Eagle Harbor to ensure their use in the best interests of the public health, order and safety of all persons using them for aquatic recreation.

#### (2) PLANNING AND DEVELOPMENT.

The Committee shall make such plans as it deems necessary for the continuing efficient operation of all harbor facilities and equipment, presenting them to the Village Board for its advice and approval, but in no case shall any contracts be let or financially obligated without the specific authorization of the Village Board.

Whereas, the buoys installed from Petersen Point south have been very successful in controlling boats and jet-skis within the no-wake zone,



As required by s. 30.77(4), Wis. Stats., please submit a signed copy of the ordinance upon passage.

The Department also approves the placement of 15 slow-no-wake waterway markers described in the enclosed application (numbered 2859). It has been noted that the map describing this placement shows 16 markers, please include an updated map with the ordinance when a signed copy is submitted for our files.

This body of water is under Federal/State jurisdiction and therefore may require a permit issued by the United State Coast Guard. A copy of this application has been forwarded to the Coast Guard who will contact the applicant within 30 days if further information is required.

The authority for the placement of waterway markers is vested in the local authority, with the village being responsible for the placement, maintenance and upkeep of the markers. The village is responsible for ensuring the markers are placed as diagrammed in the application form.

Please note the posting requirements outlined in NR 5.15, Wisconsin Administrative Code, which require a sign with a minimum of three inch lettering be posted at each public landing outlining all regulations more restrictive than state law.

The permit and this letter should be kept by the village to show proof of proper compliance with the law.



Pursuant to our recent conversation regarding water safety in Eagle Harbor, we are forwarding our application for a Waterway Marker permit (form 8700-58) along with our Village Ordinance and recent resolution to amend the No-Wake area.

During my tenure as Harbormaster, I have witnessed substantially more usage of the southern half of Eagle Harbor by all types of water craft. This, coupled with more swimming, kayaking and wind surfing, has caused the Village great concern regarding potential serious accident and injury.

Consequently, the Village recently amended our existing ordinance to limit boat traffic. It now covers a larger portion of the South half of Eagle Harbor, along with the East shoreline as "Slow, No-Wake".



# 20.04 WATER SAFETY PATROL.

(1) <u>APPOINTMENT</u>. The Village Board may appoint a chief and such other officers of a Water Safety Patrol as may be required. Each shall serve at the discretion of the Board.

(2) <u>POWERS AND DUTIES</u>. The officers of the Patrol may have the same powers as the Village constable to arrest, with or without process, all persons found to be in violation of the regulations of 20.01 of this chapter, which covers the State boating regulations, or of the special regulations adopted by the Village as set forth in this section.

(3) <u>JURISDICTION</u>. The members of the Water Safety Patrol are required to patrol the waters of Eagle Harbor as defined in 20.02(1).

(4) CHIEF OF THE WATER SAFETY PATROL.

(a) The Chief shall have command of the Water Safety Patrol of the Village and shall have custody, care and control of its property and equipment.

(b) He shall familiarize himself with s.s. 30.50-30.80, Wisc. Stats., incorporated in their entirety as part of this chapter and with the special boating regulations in sub.(5).

(c) He shall consult from time to time with the Docks/Coastal Management Committee regarding the activities, policies and goals of the Patrol.


(5) <u>SPECIAL BOATING REGULATIONS</u>. Boating regulations particularly applicable to the waters of Eagle Harbor that are under police jurisdiction of the Village have been adopted and shall be enforced by the Water Safety Patrol.

#### (a) <u>Right of Wav.</u>

1. No person shall operate a motor boat faster than the snow-nowake within that area as described as the designated mooring area in section 20.05 of this ordinance and marked by regulatory buoys and described on the map included as part of this ordinance as Appendix A.

2. Distance from Landings and Beaches. No person shall operate a boat for the purpose of towing a water-skier within 100 ft. of the outside limits of any marked public swimming area designated by

the Chief of the Harbor Safety Patrol, any swimming or diving flag or within 100 ft. of any public boat landing.

3. Exceptions. The limitations of this paragraph shall not apply to participants in ski meets or exhibitions authorized by Village of Ephraim.

(b) <u>Littering waters prohibited.</u> No person shall deposit, place or throw from any boat, raft, pier, platform or similar structure any 8cans. paper, bottles, debris, refuse, garbage, solid or liquid waste into the waters of Eagle Harbor.

(c) <u>Interference with Markers Prohibited</u>. No person shall without authority remove, damage, destroy, moor to or attach any watercraft to any buoy, beacon or marker placed in the waters of Eagle Harbor.

(d) <u>Mooring at Docks Without Permission</u>. No person shall moor a boat to a private or municipal dock or beach it upon private property within the Village without the permission of an authorized representative of the Village or the owner thereof.

(e) <u>Seaplanes</u>. No person operating a seaplane shall bring it to rest upon the waters of Eagle Harbor within 1,000 ft. of any swimming or occupied boat.


- (3) <u>Maintenance</u>. Existing facilities, including docks, marker buoys, patrol craft, lighting and other equipment shall be maintained in good usable condition, with any major expenditures subject to authorization by the Village Board before the work is undertaken as in section (2). However, if the cost of day-to-day maintanance expenses can be not through the use of funde on band from current harbor operations, no approval by the Village Board be requested.
- (4) Burth and Nuoring Peez. Subject to the approval of the Willow Board, fees shall be established for the use of public berths, moorings and other facilities. Such fees may vary according to the size of boats, the length of stay or the location of berths but, in all oncore, equal fees shall be charged for equal services. To request a contested case hearing pursuant to section 227.42, Stats., you have 30 days after the decision is mailed, or otherwise served by the Department, to serve a petition for hearing on the Secretary of the Department of Natural Resources.
